8	WHEREAS, the FY 2010 Himdag Ki: budget account 01-1508 in the amount of \$1,222,857.57 has the						
9	funds to cover the transfers in the amount of \$12,000.00 from one budget line item to						
10	another; and						
11	WHEREAS, the request for this amendment to transfer funding between the budget line items has						
12	been reviewed by the Cultural Preservation Committee, and the Budget and Finance						
13	Committee.						
14	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves						
15	the addition of Line Item 650 Tuition and Registration and Line Item 655 Lodging and						
16	authorizes the transfer of funds in accordance with the <i>Himdag Ki:</i> budget 01-1508,						
17	Amendment 1/Modification 1, attached hereto.
