5	WHEREAS, these funds are necessary for the Tohono O'odham Nation Cultural Center & Museum
6	to fulfill its mission through programs and capital expenditures; and
7	WHEREAS, the Cultural Preservation Committee and Budget and Finance Committee have
8	reviewed the request to expend these funds.

10	the establishment of a new account and the expenditure of \$71,975.05 from the Desert
