

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval to establish a new account to expend the Desert Diamond Casinos' golf contribution in the amount of \$71,975.05 for programming and capital purchases for the Tohono O'odham Nation Cultural Center & Museum)**

RESOLUTION NO. 10-124

1 WHEREAS, Desert Diamond Casinos sponsored a golf tournament in March 2009 to benefit the  
2 Tohono O'odham Nation Cultural Center & Museum; and

3 WHEREAS, the golf contribution, in the amount of \$71,975.05, is now held in a temporary account  
4 for use by the Tohono O'odham Nation Cultural Center & Museum; and

5 WHEREAS, these funds are necessary for the Tohono O'odham Nation Cultural Center & Museum  
6 to fulfill its mission through programs and capital expenditures; and

7 WHEREAS, the Cultural Preservation Committee and Budget and Finance Committee have  
8 reviewed the request to expend these funds.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
10 the establishment of a new account and the expenditure of \$71,975.05 from the Desert  
11 Diamond Casinos' golf contribution by the Tohono O'odham Nation Cultural Center  
12 & Museum, in accordance with the Cultural Center & Museum budget attached hereto.

13 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
14 Chairman and any designated official to expend and administer the budget, as  
15 attached, provided that any amendments affecting the funds or funding levels of the  
16 budget shall be submitted for further prior approval by the Tohono O'odham  
17 Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day  
19 of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article  
21 VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono  
22 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
24 Stat. 984).
