(Approval to establish a new account to expend contributions in the amount of \$22,500.00 for completion of furnishings for the Tohono O'odham Nation Cultural Center & Museum)

RESOLUTION NO. 10-125

1 **WHEREAS, two donors have contributed funding in the amount of \$22,500.00 to the Tohono**
2 **O'odham Nation Cultural Center & Museum; and**

3 **WHEREAS, the funds are now held in a temporary account for use by the Tohono O'odham Nation**
4 **Cultural Center & Museum; and**

5 **WHEREAS, these funds have been directed to be spent on the completion of furnishings that were**
6 **planned for and designed during the capital project phase of the Tohono O'odham**
7 **Nation Cultural Center & Museum; and**

8 **WHEREAS, the Cultural Preservation Committee and Budget and Finance Committee have**
9 **reviewed the request to expend these funds.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **the establishment of a new account and expenditures of \$22,500.00 from donor**
12 **restricted contributions to the Tohono O'odham Nation Cultural Center & Museum,**
13 **in accordance with the Cultural Center & Museum budget attached hereto.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Chairman and any designated official to expend and administer the budget, as**
16 **attached, provided that any amendments affecting the funds or funding levels of the**
17 **budget shall be submitted for further prior approval by the Tohono O'odham**
18 **Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH Day**
20 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article**
22 **VI, Section 1 (d)(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
