

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2010 Department of Health and Human Services Title IV-B, Subparts**  
**1 & 2 Carryover Budgets for Division of Child Welfare Services, Approving the 10%**  
**Indirect Cost Rate for Title IV- B Budgets)**

RESOLUTION NO. 10-126

1 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**  
2 **of Child Welfare Services to intervene against child abuse and neglect and to promote**  
3 **safe and stable families; and**

4 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two year expenditure**  
5 **period, beginning October 1, 2008 and ending September 30, 2010, funding only the**  
6 **two fiscal years of FY 2009 and FY 2010; and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved the Title IV-B, Subpart 1 & 2**  
8 **Carryover Budget in the allocated amounts with an Indirect Cost at 10% as:**

- 9 **1. \$11,713.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1339.**
- 10 **2. \$4,584.70 for Title IV-B, Subpart 2 Budget, Acct. 11-1340; and**

11 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**  
12 **Families (ACF), has notified the Department that The Child and Family Services**  
13 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**  
14 **starting October 1, 2007 for these Title IV -B budgets, and the Department requests**  
15 **approval to submit these budgets with the following restricted 10% amount for**  
16 **indirect costs as:**

- 17 **1. \$1,064.82 at 10% Indirect Cost for Title IV-B, Subpart 1 Carryover Budget; Acct. 11-**  
18 **1339.**
- 19 **2. No reflective Indirect Cost for Title IV-B, Subpart 2 Carryover Budget; Acct. 11-1340.**

20 **WHEREAS, these budgets have been reviewed by the Health and Human Services committee and**  
21 **Budget and Finance committee with their recommendation of approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does approve**  
23 **the FY 2010 Department of Health and Human Services Title IV-B, Subparts 1 & 2**  
24 **Carryover Budgets with an Indirect Cost to reflect the restricted 10% for Title IV-B**  
25 **Budgets, in the amounts of \$11,713.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1339**  
26 **and \$4,584.70 for Title IV-B, Subpart 2 Budget, Acct. 11-1340, these Title IV-B, Subparts**  
27 **1 & 2 Budgets are authorized for only a two year expenditure period, funding only the**  
28 **two fiscal years of FY 2009 and FY 2010.**

29 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**  
30 **Chairman and any designated official are hereby authorized to negotiate, execute and**  
31 **expend the grant.**


