RESOLUTION NO. 10-127

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on April 7, 2010 to address issues**
2 **pertaining to the Nation; and**

3 **WHEREAS, on March 27, 2010, at a regularly scheduled meeting, the Gu Achi District Council did**
4 **approve budget amendments for the District's communities and the District's**
5 **Administration; and**

6 **WHEREAS, Sikol Himatk Community had expended funds in their community's budget and**
7 **submitted a budget amendment for approval in order to meet the community's needs**
8 **(Amendment #1, Resolution #0310-163) as attached hereto; and**

9 **WHEREAS, Covered Wells Community submitted a budget amendment (Amendment #2,**
10 **Resolution #0310-165) with an amount of \$1,500.00 decreased from line item #750**
11 **Major Capital Equipment and a decrease of \$8,000.00 from item #861 Miscellaneous**
12 **to include new line items for #710 Utilities for an amount of \$8,000.00 and #724**
13 **Kitchen Supplies for an amount of \$1,500.00; and**

14 **WHEREAS, amendments were also made to the Covered Wells Community's budget justification**
15 **line items as listed:**

#721 Supplies-Other	The request will be for one time assistance and requester must be present and approved at a Covered Wells Community meeting.
#727 Building Materials	Quotes are required and requester must be present and approved at a community meeting.
#854 Clothing Allowance	Students employed with the Community Summer Youth Program are not eligible if they worked the previous year.
#865 Emergency Assistance	To provide assistance to community members affected by unforeseen events and natural disasters that are beyond a person's control and will be determined by the damage, with a cap of \$500.00.; and

23 **Verde Stand Community (*Amendment #2*) and the Gu Achi District Administration**
24 **(*Amendment #1*) as attached hereto.**

25 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
26 **Distribution of \$1,863,072.77 to the Gu Achi District.**

27 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
28 **Year 2010 budget in accordance with protocols set forth by this Council. Any**
29 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**
30 **2010 budget shall be approved by the Tohono O'odham Legislative Council.**

31 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**
