RESOLUTION NO. 10-135

1 **WHEREAS, resolution number 09-600 of the Tohono O'odham Legislative Council enacted, on**
2 **November 18, 2009 approved the San Lucy District FY 2010 Budget; and**

3 **WHEREAS, by Resolution Number SL 02-15-10 the San Lucy District Council approved the Elderly**
4 **Program Budget Modification Number 1, wherein, budget saving from vacant**
5 **Custodial Care Aide position in the amount of \$5,000.00 were reallocated to line item**
6 **660 Travel Expenses to cover additional trips by the elders to various locations; and**

7 **WHEREAS, the Tohono O'odham Legislative Council Budget and Finance Committee reviewed the**
8 **San Lucy District Elderly Program Budget modification and determined that**
9 **reallocation of funds constitute a budget amendment.**

10 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves San**
11 **Lucy District FY 2010 Elderly Program Budget Amendment number 1, as attached**
12 **hereto.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
14 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,389.20 FOR; -0-**
15 **AGAINST; -0- NOT VOTING; and 206.30[05] ABSENT, pursuant to the powers vested in the Council**
16 **by Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the**
17 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**
