7		obtained by the Division of Senior Services is applied to the Arizona Long Term Care
8		Services (ALTCS) Program Base Budget (14-1416) for current and future program
9		operations; and
10	WHEREAS,	the Division of Senior Services Program has identified FY 2009 carryover balance from
11		the previous year budget in the amount of \$75,756.34 to be applied to the ALTCS base
12		budget; and
13	WHEREAS,	the attached Arizona Long Term Care Services (ALTCS) FY 2010 Budget Amendment No
14		1 has been prepared to utilize FY 09 carryover to increase Salaries & Fringe Benefits.

22		program operations.
23		2. The Division of Senior Services Program to carryover balance from the previous
24		year budget in the amount of \$75,756.34 and be applied to the ALTCS base budget
25		to increase Salaries, Fringe Benefits, Communication, Supplies-Office, Supplies-
26		Other line items and new line items, Utilities and RM Equipment.
27		3. The Tohono O'odham Nation's officials to wit: the Chairman, Vice Chairman, and
28		any designated official are hereby authorized to negotiate and execute the grant
29		provided however, that any amendment affecting the funding or funding levels of
30		this contract shall be submitted for further prior approval by this Council.
