1	WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and
2	Corrections Programs under the 638 BIA Master Contract; and
3	WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has amended the budget by
4	decreasing the line item 620 Fringe Benefits by \$49,368.22; and
5	WHEREAS, this decrease is due to an error that was found in the personnel pages of the 2010
6	budget which was calculated into the fringe line item; and
7	WHEREAS, with this reduction the line item has been corrected to reflect the correct amount for
8	fringe benefits; and
9	WHEREAS, the amount of \$49,368.22 has been redistributed into operational line items 712 Gas,
10	oil, & coolants in the amount of \$34,168.22 and 723 Uniforms in the amount of
11	\$15,200.00; and
12	WHEREAS, the decrease has not changed to bottom line.
13	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby,
14	approves and authorizes Budget Amendment No. 1 for the FY 2010 638 Ranger
15	Program budget with decrease in line item 620 Fringe Benefits in the amount of
16	\$49,368.22 to correct the fringe benefits line item, redistribution of funds into new
17	operational line items 712 Gas, oil & coolants in the amount of \$34,168.22 and 723
18	Uniforms in the amount of \$15,200.00 with no change to the bottom line.
19	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes the
20	Chairman and any designated official to expend and administer the budget as
21	attached, provided that any amendments affecting the funds or funding level shall be
22	submitted for further prior approval by the Tohono O'odham Legislative Council.
