11	1. The Tohono O'odham Legislative Council approves the Attorney Contract with the
12	law firm of Patton Boggs, LLP in the amount of \$220,000.00 for FY2010, for the
13	period from April 16, 2010 to September 30, 2010, substantially in the form
14	attached hereto.
15	2. Funding for the Attorney Contract will come from the Economic Developmen
16	Budget.
17	3. The Chairperson of the Nation is authorized and directed to execute the Attorney
18	Contract.
