

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Attorney Contract for FY2010 with the Law Firm of Patton Boggs, LLP)**

RESOLUTION NO. 10-145

1 **WHEREAS, the Office of Attorney General requires the legal services of the law firm of Patton**
2 **Boggs, LLP to represent the Tohono O'odham Nation in matters relating to the West**
3 **Valley Resort project; and**

4 **WHEREAS, the Attorney General has recommended a budget of \$220,000 for fiscal year 2010 for**
5 **the period from April 16, 2010 to September 30, 2010; and**

6 **WHEREAS, the funding for this Attorney Contract will come from the Economic Development**
7 **Budget; and**

8 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed this attorney**
9 **contract and recommend approval by the Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves the Attorney Contract with the**
12 **law firm of Patton Boggs, LLP in the amount of \$220,000.00 for FY2010, for the**
13 **period from April 16, 2010 to September 30, 2010, substantially in the form**
14 **attached hereto.**
- 15 **2. Funding for the Attorney Contract will come from the Economic Development**
16 **Budget.**
- 17 **3. The Chairperson of the Nation is authorized and directed to execute the Attorney**
18 **Contract.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
20 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0-**
21 **AGAINST; -01- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
