6		Department of Health and Human Services, as the Nation's public health authority;

8	WHEREAS,	the Tohono O'odham Nation did enter into an Intergovernmental Agreement (IGA),
9		Contract No. HG954111, with the Arizona Department of Health Services (ADHS) for
10		(Public Health) Emergency Preparedness and Response with a start date of August 9,
11		2008 (terminating on 08/08/2013); and
12	WHEREAS,	the ADHS IGA, Contract No. HG954111, was approved by the Tohono O'odham
13		Legislative Council by Resolution No. 09-123; and
14	WHEREAS,	the \$80,000.00 ADHS FY 2010 BT funding notice was received and a budget prepared
15		and approved in Resolution No. 09-593; and
16	WHEREAS,	the FY 2010 Public Health Preparedness and Response - Bioterrorism Budget
17		Amendment #1 now moves identified savings of \$25,429.82 from salary, fringe and
18		Indirect Cost; and
19	WHEREAS,	the 810 Professional Services line item is increased by the same amount of \$25,429.82.
20	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby:
21		1. Approves the FY 2010 Public Health Preparedness and Response - Bioterrorism,
22		Budget Amendment #1; the decrease from salary of \$15,900.70 and decrease from
23		Fringe Benefits of \$5,406.23; and an increase to 810 Professional Services line of
24		\$25,429.82.
25		2. Approve a decrease of \$4,122.89 to Indirect Cost.
