

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Legislative Branch FY 2010 Budget Amendment No. 2)**

**RESOLUTION NO. 10-148**

1 **WHEREAS, the Legislative Council is authorized “to manage any funds within the exclusive**  
2 **control of the Tohono O’odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members “provided that” [a]ll expenditures of these funds**  
4 **shall be pursuant to appropriations or budgets” authorized by resolution or**  
5 **ordinance (Constitution of the Tohono O’odham Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its**  
7 **Legislative Branch FY 2010 Budget Amendment No. 2 (which is incorporated by this**  
8 **reference) in the amount of \$82,964.70; and**

9 **WHEREAS, the Legislative Branch FY 2010 Budget Amendment No. 2 provides for additional**  
10 **personnel and operational expenses and does not change the approved FY 2010**  
11 **Legislative Branch budget total amount of \$3,289,869.84; and**

12 **WHEREAS, Legislative Branch FY 2010 Budget Amendment No. 2 would increase line items 612-**  
13 **Occasional Appointment by \$9,000.00; 620-Fringe Benefits by \$990.00; 640-Committee**  
14 **Fee by \$5,000.00; 655-Lodging by \$10,000.00; 660-Travel by \$10,000.00; 711-**  
15 **Communication Expenses by \$10,000.00; 721-Supplies – Other by \$28,022.41; 812-**  
16 **Public Relations by \$9,952.29 and decrease line items 610-Salaries by \$27,585.60; 620-**  
17 **Fringe Benefits by \$9,379.10; 751-Lease/Rentals by \$3,000.00; 771-RM Vehicles by**  
18 **\$10,000.00; 774-Computer Maintenance by \$30,000.00; and 778-Alteration and**  
19 **Renovations by \$3,000.00; and**

20 **WHEREAS, there are sufficient funds in the Legislative Branch FY 2010 budget to support the**  
21 **proposed Legislative Branch FY 2010 Budget Amendment No. 2; and**

22 **WHEREAS, the Legislative Branch FY 2010 Budget Amendment No. 2 has been reviewed by the**  
23 **Budget and Finance Committee.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O’odham Legislative Council that it hereby**  
25 **approves Legislative Branch FY 2010 Budget Amendment No. 2 in the amount of**  
26 **\$82,964.70 to increase line items 612-Occasional Appointment by \$9,000.00; 620-Fringe**  
27 **Benefits by \$990.00; 640-Committee Fee by \$5,000.00; 655-Lodging by \$10,000.00; 660-**  
28 **Travel by \$10,000.00; 711-Communication Expenses by \$10,000.00; 721-Supplies –**  
29 **Other by \$28,022.41; 812-Public Relations by \$9,952.29 and decrease line items 610-**  
30 **Salaries by \$27,585.60; 620-Fringe Benefits by \$9,379.10; 751-Lease/Rentals by**

2                   **and 778-Alteration and Renovations by \$3,000.00 which does not change the approved**  
3                   **FY 2010 Legislative Branch budget total amount of \$3,289,869.84.**

4 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**  
5                   **Legislative Council Chairperson and Vice-Chairperson to administer the attached**  
6                   **budget, provided however, that any amendments that change the aggregate total of**  
7                   **funds originally budgeted or that change the purpose for which the funds were**  
8                   **budgeted shall be submitted for prior approval by the Tohono O'odham Legislative**  
9                   **Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
11 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and 198.7[05] ABSENT, pursuant to the powers vested in the Council by**  
13 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
14 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**


