

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 to Attorney Contract with the Law Firm of Gammage
and Burnham, P.L.C.)**

RESOLUTION NO. 10-150

1 **WHEREAS, by Resolution No. 09-562 the Nation approved an Attorney Contract in the amount of**
2 **\$220,000 with the law firm of Gammage and Burnham, P.L.C., funded by the Economic**
3 **Development Budget; and**

4 **WHEREAS, the Attorney General recommends approval of Amendment No. 1 to the Attorney**
5 **Contract, which adds \$210,000 to the budget for the Attorney Contract; and**

6 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment**
7 **No. 1 to the Attorney Contract and recommend approval by the Legislative Council.**

8 **NOW, THEREFORE, BE IT RESOLVED that:**

- 9 **1. The Tohono O'odham Legislative Council hereby approves Amendment No. 1 to the**
10 **Attorney Contract with the law firm of Gammage and Burnham, P.L.C., which adds**
11 **\$210,000 to the budget for the Attorney Contract, substantially in the form**
12 **attached hereto.**
- 13 **2. Funding for Amendment No. 1 to the Attorney Contract will come from the**
14 **Economic Development Budget.**
- 15 **3. The Chairperson of the Nation is authorized and directed to execute Amendment**
16 **No. 1 to the Attorney Contract with the law firm of Gammage and Burnham, P.L.C.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28TH Day**
18 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and 198.7[06] ABSENT, pursuant to the powers vested in the Council by**
20 **Article VI, Section 2 (a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
21 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
22 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
23 **Stat. 984).**
