8	WHEREAS, the Human Resources Development Committee and the Domestic Affairs Committee
9	have reviewed and the IGA (Intergovernmental Agreement, DE101030-001).
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
11	accept, approve, and authorize the FY 2010 Intergovernmental Agreement, DE101030-
12	001 for Education Department-One Stop Division/Department of Economic Security-
13	State of Arizona.
14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman is hereby
15	authorized to sign and execute the Intergovernmental Agreement, provided however,
16	that any amendment affecting the funding or funding levels of the budget shall be
17	submitted for further prior approval by the Legislative Council.
