

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving a Intergovernmental Agreement [IGA] DE101030-001 with the Arizona  
Department of Economic Security for the One Stop Division of the Education Department)**

**RESOLUTION NO. 10-151**

1 **WHEREAS, the Arizona Department of Economic Security is intended to fund specific Workforce**  
2 **Investment Act (WIA) employment and training programs operated by the Tohono**  
3 **O'odham Nation Education Department's One Stop Division Intergovernmental**  
4 **Agreement DE101030-001 for the period beginning April 1, 2009 to June 30, 2012; and**

5 **WHEREAS, the Department of Economic Security - State of Arizona has allocated funds to the**  
6 **Nation, for FY2010 in the amount of \$210,283.00, the funds allocated are subject to the**  
7 **provisions of the Workforce Investment Act Title 1B; and**

8 **WHEREAS, the Human Resources Development Committee and the Domestic Affairs Committee**  
9 **have reviewed and the IGA (Intergovernmental Agreement, DE101030-001).**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
11 **accept, approve, and authorize the FY 2010 Intergovernmental Agreement, DE101030-**  
12 **001 for Education Department - One Stop Division/Department of Economic Security-**  
13 **State of Arizona.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chairman is hereby**  
15 **authorized to sign and execute the Intergovernmental Agreement, provided however,**  
16 **that any amendment affecting the funding or funding levels of the budget shall be**  
17 **submitted for further prior approval by the Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
19 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**  
20 **AGAINST; -0- NOT VOTING; and 198.7[06] ABSENT, pursuant to the powers vested in the Council by**  
21 **Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
22 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
24 **Stat. 984).**
