2 **District's FY 2009 Carry Forward Amounts; and**

3 **WHEREAS, the Schuk Toak District was allocated Gaming Revenue in the amount of \$1,863,072.77**  
4 **for FY 2010; and**

5 **WHEREAS, the Schuk Toak District Council at a meeting held on April 10, 2010 with a quorum**  
6 **present, did review and approve the District FY 2009 Carry Forward funds; and**

7 **WHEREAS, the following eight communities did present their FY 2009 Carry Forward budgets as**  
8 **part of the new total FY 2010 District Budgets:**

23 **\$19,000.00 of that amount will be incorporated into the FY 2010 Summer Youth**  
24 **Program budget, the remaining \$12,673.29 will be utilized in the District**  
25 **Administration's FY 2010 budget. The Summer Youth Program has added new lines**  
26 **to its current budget, namely, *810-Professional Services, 813-Consultants and 850-***  
27 ***Food*; and**

28 **WHEREAS, the current District's Summer Youth Program FY 2010 budget of \$70,826.00 has been**  
29 **revised to a new total of \$89,826.00; and**

30 **WHEREAS, the District's Administration FY 2009 Carry Forward amount is \$942,039.17 and will**  
31 **utilize \$12,673.29 from the Summer Youth Program Carry Forward. The**  
32 **Administration has added new line items to the current FY 2010 budget, namely, *655-***  
33 ***Lodging and 725-Well Supplies*; and**

20 **\$31,673.29, which \$19,000.00 of that amount will be incorporated into the FY 2010**  
21 **Summer Youth Program budget, the remaining \$12,673.29 will be utilized in the**  
22 **District Administration's FY 2010 budget.**

23 **BE IT FURTHER RESOLVED that new line items have been added to the current FY 2010 Summer**  
24 **Youth Program budget, namely, 810-Professional Services, 813-Consultants and 850-**  
25 **Food.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2009**  
27 **District Administration Carry Forward amount of \$942,039.17, plus the remainder of**  
28 **\$12,673.29 from the Summer Youth Program Carry Forward to be incorporated into**  
29 **the current FY 2010 District Administration Budget of \$1,027,246.77, bringing it to a**  
30 **new total of \$1,981,959.23.**

31 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the Schuk Toak**  
32 **District Administration's new line items to be added to the current FY 2010 budget,**  
33 **namely, 655-Lodging and 725-Well Supplies.**

4 **\$3,213,409.35 and to be expended accordingly to the attached budgets.**

5 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
6 **Nation's Officials, to wit; Chairperson, Vice Chairperson and any official appointed**  
7 **designee is hereby authorized to execute the budget, provided however, that any**  
8 **amendments affecting the funding or funding level of this budget shall be submitted**  
9 **for further prior approval by this Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 28<sup>TH</sup> Day**  
11 **of APRIL, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0-**  
12 **AGAINST; -0- NOT VOTING; and 198.7[06] ABSENT, pursuant to the powers vested in the Council by**  
13 **Article VI, Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
14 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
16 **18, 1934 (48 Stat. 984).**
