

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Confirming the Nomination of Barbara Nunez to the Community Development
Financial Institution Board)**

RESOLUTION NO. 10-164

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to "provide for,**
2 **appoint, or provide for the appointment of, and prescribe the duties and powers of**
3 **committees, boards, officers and agents (Article VI, Section 1(b) Constitution of the**
4 **Tohono O'odham Nation); and**

5 **WHEREAS, the Legislative Council has adopted the "Charter Community Development Financial**
6 **Institution of the Tohono O'odham Nation," which established the Community**
7 **Development Financial Institution ("CDFI") as an enterprise of the Tohono O'odham**
8 **Nation and the CDFI Board ("Board") (Charter, Article I); and**

9 **WHEREAS, the Charter establishes a Board consisting of five Directors who serve three year terms**
10 **and hold office until his or her successor has been appointed and qualified (Charter,**
11 **Article V, 5.1.6.); and**

12 **WHEREAS, "any vacancy on the Board because of death, resignation, removal or other cause shall**
13 **be filled for the unexpired portion of the term in the manner prescribed herein for**
14 **appointment of Directors" (Charter, Article V, 5.2.3); and**

15 **WHEREAS, the Charter provides that the Chairperson of the Nation shall nominate Directors to**
16 **the CDFI Board, with confirmation by the Legislative Council (Article V, 5.1.2.); and**

17 **WHEREAS, Ms. Sally Martinez's term expired on September 30, 2006 (Resolution No. 05-488), but**
18 **she continued to serve until her resignation on February 18, 2009; and**

19 **WHEREAS, no one was appointed for the remainder of the term which expired on September 30,**
20 **2009 or to the new term that began on October 1, 2009 and will expire on September**
21 **30, 2012; and**

22 **WHEREAS, the Chairman of the Nation has determined that Ms. Barbara Nunez is qualified and**
23 **has nominated her to the CDFI Board; and**

24 **WHEREAS, Ms. Barbara Nunez has accepted the nomination subject to confirmation by the**
25 **Tohono O'odham Legislative Council; and**

26 **WHEREAS, the Legislative Council Commerce Committee and Rules Committee have reviewed the**
27 **Chairman's nomination.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council confirms the**
29 **appointment of Ms. Barbara Nunez to the CDFI Board beginning on the effective date**
30 **of this resolution and ending on September 30, 2012, provided that she shall continue**
31 **to serve until her successor has been appointed and qualified.**
