

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment 3 to the FY2010 Budget 01-1020 to adjust line items within
the Accounting Budget to meet the changing needs of the Department)**

RESOLUTION NO. 10-167

1 **WHEREAS, the Tohono O'Odham Legislative Council approved the FY2010 Accounting Budget 01-**
2 **1020, in the amount of \$2,829,132.90 with Resolution No. 09-268; and further increased**
3 **the budget with Amendment No. 1 with Resolution No. 09-605 to \$3,068,445.38; and**

4 **WHEREAS, the Accounting Department is requesting the Tohono O'Odham Legislative Council to**
5 **approve increasing line item 720 Supplies Office by \$6,700.00; line item 721 Supplies-**
6 **Other \$7,156.00; and line 750 Major Capital by \$2,144.00. To provide for no increase**
7 **in the total budget the following line item 650 Tuition and Registration will be**
8 **decreased by \$16,000.00; and**

9 **WHEREAS, the Accounting Department has assessed the needed change to Budget 01-1020 with**
10 **Amendment No. 3 and presented the amendment to the Budget and Finance**
11 **Committee for review.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**
13 **approves Amendment No. 3 to increase the following line items 720 Supplies Office by**
14 **\$6,700.00; 721 Supplies-Other \$7,156.00; and line 750 Major Capital by \$2,144.00 and**
15 **to decrease line item 650 Tuition and Registration \$16,000.00 resulting in no increase**
16 **or decrease to the overall current budgeted amount.**

17 **BE IT FINALLY RESOLVED that the Tohono O'Odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget, as**
19 **attached, provided that any amendments affecting the funds or funding levels of the**
20 **budget shall be submitted for further prior approval by the Tohono O'Odham**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of MAY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
