

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting May 21, 2010 Special Session for the Tohono O'odham Ki:Ki Association to**  
**Present a Quarterly Update)**

LEGISLATIVE ORDER NO. 10-168

1 **WHEREAS, the Legislative Council is vested with the power “to establish rules and procedures to**  
2 **regulate all meetings of the Tohono O'odham Council, standing committees, boards**  
3 **and special committees.” (Constitution of the Tohono O'odham Nation, Article VI,**  
4 **Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the Council with**  
6 **the authority to “by majority vote, call for a special session” (Legislative Rules of the**  
7 **Tohono O'odham Legislative Council, Article I, Section 1.D.1.); and**

8 **WHEREAS, the Legislative Council Housing Committee has requested a special session for May 21,**  
9 **2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki Association to present a quarterly**  
10 **update.**

11 **NOW THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**  
12 **Special Session for May 21, 2010 at 9:00 a.m. for the Tohono O'odham Ki:Ki Association**  
13 **to present a quarterly update.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> day of**  
15 **MAY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
16 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
17 **Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**  
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
