1	WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures to
2	regulate all meetings of the Tohono O'odham Council, standing committees, boards
3	and special committees." (Constitution of the Tohono O'odham Nation, Article VI
4	Section 1(a)); and
5	WHEREAS, Article I, Section 2.C. of the Legislative Rules of the Tohono O'odham Legislative
6	Council, as amended, provides that "[a]ll Legislative Council sessions shall be held at
7	the Tohono O'odham Legislative Council chambers located in Sells, Tohono O'odham
8	Nation, with the following exceptions [a] majority of all the legislative
9	representatives may vote to hold a session in some location other than the chambers
10	located at Sells."; and
11	WHEREAS, the Legislative Rules Committee has recommended that the Legislative Council attended to $oldsymbol{1}$
12	the Tohono O'odham Nation Constitution Educational Review during the May 14, 2010
13	general session; and
14	WHEREAS, the Legislative Rules Committee further recommends that the Legislative Rules, with
15	the exception of attendance and roll call provisions in Article II and Article III, Section
16	1, be suspended for the May 14, 2010 general session.
17	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that
18	1) The May 14, 2010 general session shall be held at Baboquivari High School Fine
19	Arts Building for Tohono O'odham Nation Constitution Educational Review and
20	roll call shall be conducted at 9:00 a.m.
21	2) The Legislative Rules, with the exception of attendance and roll call provisions in
22	Article II and Article III, Section 1, shall be suspended for the May 14, 2010 genera
