7	WHEREAS, the total allocation was portioned among the four communities to address the needs
8	according to the budgets submitted; and
9	WHEREAS, the Ge Oidag (Big Field) Community was allocated \$66,649.23 in FY 2009 of the Mining
10	Royalties; and
11	WHEREAS, the Ge Oidag (Big Field) Community has a remaining balance of \$29,696.64 which the
12	community has requested to carryover this amount with Ge Oidag (Big Field)
13	Community Resolution No. GO-47-2010 which was also approved by Sells District
14	Council with Resolution No. SD-35-10.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
16	the Carryover of Ge Oidag (Big Field) Community Fiscal Year 2009 Mining Royalties to
17	FY2010 in the amount of \$29,696.64 with the attached budget and it's justification.
18	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Sells
19	District Chairperson and any designated official to expend and administer the budget
20	according to its justification, as attached, provided that any
21	modifications/amendments affecting the funds or funding levels of the budget shall
22	be submitted for further prior approval by the Tohono O'odham Legislative Council.
