

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Ge Oidag (Big Field) Community Carryover of 1st Supplement from
Fiscal Year 2009 to Fiscal Year 2010)**

RESOLUTION NO. 10-171

1 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 99-550 approved a \$500,000.00**
2 **Supplemental Budget for the Sells District in Fiscal Year 2000; and**

3 **WHEREAS, the Sells District portioned out the supplement fund in the amount of \$58,000.00 to**
4 **each of the four communities that make up the Sells District; and**

5 **WHEREAS, the Ge Oidag (Big Field) Community currently has a balance available of \$11,019.19 of**
6 **the Supplemental Budget from Fiscal Year 2009 to be carried over into Fiscal Year**
7 **2010; and**

8 **WHEREAS, the attached budget and justification has been prepared and approved by Ge Oidag**
9 **(Big Field) Community Resolution No. GO-46-2010; and by Sells District Council**
10 **Resolution No. SD-34-10.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Carryover of \$11,019.19 from the balance of the 1st Supplemental Budget for Ge Oidag**
13 **(Big Field) Community from Fiscal Year 2009 to Fiscal Year 2010.**

14 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
15 **Sells District Chairperson and any designated official to expend and administer the**
16 **budget according to its justification as attached, provided that any**
17 **modifications/amendments affecting the funds or funding levels of the budget shall**
18 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
20 **of MAY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
25 **Stat. 984).**
