- 1 **WHEREAS, the Tribal Herd Program has been in existence since 1941 for the purpose of an**
2 **experimental herd/range management for cattle rotation, as a source of generating**
3 **revenue for the Tohono O'odham Nation; and**
- 4 **WHEREAS, the present well was drilled in 1943 and with the advisement of the Water Resources**
5 **Department a new well needs to be drilled; and**
- 6 **WHEREAS, with the drilling of a new well it would not only benefit the Tribal Herd Program, but**
7 **also the Healthy O'odham Promotional Program and aid in future development in the**
8 **area; and**
- 9 **WHEREAS, the Tohono O'odham Legislative Council approved the Natural Resources**
10 **Department-Tribal Herd FY10 budget 01-1505 by Resolution 09-268 in the amount of**
11 **\$137,374.83; and**
- 12 **WHEREAS, the Natural Resources Department-Tribal Herd is requesting the approval by Budget**
13 **Amendment No. 1 to account number 01-1505 to appropriate funds from the**
14 **Southern Arizona Water Rights Settlement Act Trust Fund, in the amount of**
15 **\$383,560.00 for a total revised budget of \$520,934.83; and**
- 16 **WHEREAS, the Natural Resources Department-Tribal Herd is requesting that the additional**
17 **funding be used to drill a 900 foot well, to construct/implement a 3.5 mile water line**
18 **distribution system for the purpose of watering the Nation's herd and to purchase**
19 **capital equipment, two work trucks; and**
- 20 **WHEREAS, the allocated Southern Arizona Water Rights Settlement Act Trust funds is a one-time**
21 **allocation and funds not utilized during FY2010 be carried over into Fiscal Year 2011**
22 **to complete the vital projects; and**
- 23 **WHEREAS, budget amendment no. 1 to the FY 2010 account 01-1505 has been reviewed and**
24 **recommend approval by the Legislative Agricultural Committee, Budget and Finance**
25 **Committee, and reviewed by the Water Resources Committee.**
- 26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
27 **budget amendment 1 to the Natural Resources Department-Tribal Herd FY 2010**

- 1 **1. Appropriate funds from the Southern Arizona Water Right Settlement Act Trust**
- 2 **Fund, in the amount of \$383,560.00, for a total revised budget of \$520,934.83.**
- 3 **2. To create 810 Professional Services to use the funds to drill a 900 ft. well and to**
- 4 **construct/implement into service a 3.5 mile water line distribution system to**
- 5 **irrigate pasture for the purpose of watering the Nation's herd and to create new**
- 6 **line item 750, capital equipment to purchase two work trucks, in accordance**
- 7 **with the budget attached hereto.**
- 8 **3. The allocated Southern Arizona Water Rights Settlement Act Trust Funds is a**
- 9 **one-time allocation and funds not utilized during FY2010 be carried over into**
- 10 **Fiscal Year 2011 to complete the vital projects.**

11 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**

12 **Chairperson and any designated official to expend and administer the budget, as**

13 **attached, provided that any amendments affecting the funds or funding levels of the**

14 **budget shall be submitted for further prior approval by the Tohono O'odham**

15 **Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**

17 **of MAY, 2010 at a meeting at which a quorum was present with a vote of 1,639.0 FOR; 726.40**

18 **AGAINST; 230.10 [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**

19 **by Article VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**

20 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**

21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**

22 **18, 1934 (48 Stat. 984).**
