

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2011 Title XX Budget)

RESOLUTION NO. 10-174

1 WHEREAS, the Tohono O'odham Nation provides services to improve the availability,
2 affordability and quality of child care through funding provided by the Arizona
3 Department of Economic Security's (A.D.E.S.) Planned Social Services Block Grant
4 (S.S.B.G.) Title XX Program; and

5 WHEREAS, the Tohono O'odham Nation has consistently supported the nurturance of its young
6 members by providing for their welfare through various programs and services
7 designed to meet their special needs; and

8 WHEREAS, the Tohono O'odham Nation's Division of Early Childhood Development is submitting
9 for review and approval the FY 2011 Title XX Budget in the amount of \$120,644.00.


10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
11 approve and authorize the Division of Early Childhood Development to incur
12 expenditure on a reimbursement basis from the general fund from June 1, 2010 to
13 June 30, 2011 under the FY 2011 A.D.E.S./S.S.B.G Title XX Grant Program Budget in the
14 amount of \$120,644.00 as attached hereto.

15 1. Title XX Block Grant Program - \$120,644.00

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
17 Nation's Official, to wit: the Chairperson and any designated official are authorized to
18 negotiate and expend the budget, provided however, that any amendments affecting
19 the funds or funding levels of the budget shall be submitted for further prior approval.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day
21 of MAY, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,
23 Section 1 (d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
24 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).
