12	June 2010 - June 2011," in accordance with the Legislative Rules and recommends its
13	adoption.
14	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby
15	adopts the attached "Tohono O'odham Legislative Council Calendar June 2010 - June
