

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Cardiovascular Disease (CVD) Risk Reduction in Diabetes Clients Grant,
Special Diabetes Program for Indians Competitive Grant #1 H1D94 000537-01
October 1, 2009 - September 30, 2010)

RESOLUTION NO. 10-196

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2010 with a base budget of \$397,100.00; and**

3 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of 1997;**
6 **and**

7 **WHEREAS, by Resolution Number 04-287, the Tohono O'odham Legislative Council approved the**
8 **name change of the Cardiovascular Risk Reduction Prevention Program to the**
9 **Healthy Heart Project; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services is seeking approval**
11 **of an increase to its Division of Health Promotion Program, CVD Risk Reduction**
12 **(Healthy Heart Project) budget of \$397,100.00 through FY 2010 carryover amount of**
13 **\$106,085.25; and**

14 **WHEREAS, the Indirect Cost Rate (IDC) to the budget has changed from 19.35% to 17.31%**
15 **increasing from \$31,721.19 by \$1,882.15 to \$33,603.34.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 17 **1. Approves and authorizes the expenditure of the FY 2009 carryover amount of**
18 **\$106,085.25 into the Division of Health Promotion Program, CVD Risk Reduction**
19 **(Healthy Heart Project) FY 2010 Budget of \$397,100.00 to increase the total budget**
20 **to \$503,185.25.**
- 21 **2. Approves an increase of \$1,882.15 to the Indirect Cost Rate (IDC) of 17.31% for a**
22 **new IDC total of \$33,603.34.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby approves and**
24 **authorizes the Chairman, Vice-Chairman and any designated official to expend and**
25 **administer the budget as attached, provided that any amendments affecting the funds**
26 **or funding level shall be submitted for further final approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH Day**
29 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
30 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
31 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
32 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
33 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
