RESOLUTION NO. 10-198

1 **WHEREAS, the Department of Health and Human Services, Division of Management of Health**
2 **directs services that provide substance abuse, mental health, and prevention services;**
3 **and**

4 **WHEREAS, the Division of Management of Health received the Strategic Prevention Framework**
5 **Tribal Incentive Grant to design and implement a Tohono O'odham Nation Strategic**
6 **Plan establish prevention programs within each District to reduce substance abuse**
7 **and related health problems that include suicide, diabetes, depression, fetal alcohol**
8 **syndrome and premature death rates; and**

9 **WHEREAS, the amounts of \$31,500 for 810 Professional Services and \$23,500 for 813 Consultants**
10 **be decreased; and**

11 **WHEREAS, this establishes new line items 626 Allowances and Stipends, 661 Mileage POV and 860**
12 **Special Activities and increase Indirect Costs; and**

13 **WHEREAS, the amended budget of total budget \$600,800 for FY 2010 was reviewed and approved**
14 **by Health and Human Services Committee and Budget & Finance Committee.**

15 **NOW, THEREFORE BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 16 **1. Approves decreases of \$31,500 for line item 810 Professional Services and \$23,500**
17 **for line item 813 Consultants.**
- 18 **2. Approves new line item 626 Allowances and Stipends of \$21,000, line item 661**
19 **Mileage POV of \$19,312, line item 860 Special Activities of \$9,175.64 and increase**
20 **Indirect Costs of \$5,512.36.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairperson and any designated official to expend and administer the budget as**
23 **attached, provided that any amendments affecting the funds or funding level shall be**
24 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
26 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI,**
28 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
