**RESOLUTION NO. 10-202** 

1	WHEREAS, the Tohono O'odham Legislative Council Resolution No. 07-752 in Fiscal Year 2007
2	approved the Equal Distribution of \$2,932,566.45 of Mining Royalties to the eleven
3	Districts of the Tohono O'odham Nation; and
4	WHEREAS, the Sells District's portion of this allocation in the amount of \$266,596.95 was
5	requested and approved to be utilized in Fiscal Year 2009 with Sells District Resolution
6	No. SD-22-09 and Tohono O'odham Legislative Council Resolution No. 09-140; and
7	WHEREAS, the total allocation was portioned among the four communities to address the needs
8	according to the budgets submitted; and
9	WHEREAS, the Sells Community was allocated \$66,649.24 in FY 2009 of the Mining Royalties; and
10	WHEREAS, the Sells Community has a remaining balance of \$51,207.83 which the community has
11	requested to carryover this amount with Sells Community Resolution No.SC-66-10
12	which was also approved by Sells District Council with Resolution No. SD-42-10; and
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
14	Carryover of Sells Community Fiscal Year 2009 Mining Royalties to FY2010 in the
15	amount of \$51,207.83 with the attached approved budget and it's justification.
16	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
17	Sells District Chairperson and any designated official to expend and administer the
18	budget according to its justification, as attached, provided that any
19	modifications/amendments affecting the funds or funding levels of the budget shall
20	be submitted for further prior approval by the Tohono O'odham Legislative Council.
