

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(To Accept and Authorize to Expend \$620,000.00 from Indian Health Service (I.H.S.)  
Memorandum of Agreement funded by the American Recovery and Reinvestment  
Act (ARRA) Project TU09-900 for the Solid Waste Management Program FY2010  
I.H.S. {New Acct # needed;})**

**RESOLUTION NO. 10-204**

1 **WHEREAS, the Tohono O'odham Legislative Council approved a Memorandum of Agreement**  
2 **between the Tohono O'odham Nation Solid Waste Management Program (SWMP) and**  
3 **the Indian Health Service (I.H.S.) through Resolution No. 97-041; and**

4 **WHEREAS, the I.H.S. has secured funding through the ARRA for \$620,000 to clean-up and close**  
5 **eight (8) dump sites in FY-2010; and**

6 **WHEREAS, the ARRA funding is for stimulating the economy through the preservation and**  
7 **creation of jobs; and**

8 **WHEREAS, the proposed budget will create three new positions and preserve six existing positions**  
9 **currently in 10-1097 budget; and**

10 **WHEREAS, the Solid Waste Management Program budget FY2010 for I.H.S. ARRA Project TU 09-900**  
11 **budget has been reviewed by the Legislative Natural Resources Committee and the**  
12 **Legislative Budget and Finance Committee.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
14 **acceptance and expenditure of \$620,000.00, from the I.H.S. Memorandum of**  
15 **Agreement, for the Solid Waste Management Program FY2010 I.H.S. ARRA Project TU**  
16 **09-900 six month budget [NEED ACCT #], in accordance with the budget attached**  
17 **hereto and retroactive from April 1, 2010 thru September 30, 2010.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
19 **Nation's Officials, to wit: the Chairperson and any designated official are authorized**  
20 **to negotiate and execute the agreement, provided however, that any amendments**  
21 **affecting the funds or funding levels of the agreement shall be submitted for further**  
22 **approval.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
24 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,068.45 FOR; 92.25**  
25 **AGAINST; 230.10 NOT VOTING; and 204.70 [06] ABSENT, pursuant to the powers vested in the**  
26 **Council by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat. 984).**
