

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing a Request for Mature Contract Status regarding the Nation's P.L. 93-638
Indian Health Service Master Contract)

RESOLUTION NO. 10-205

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Indian Health Service; and**

3 **WHEREAS, the term of the Nation's Indian Self-Determination Master Contract with Indian**
4 **Health Service has been for three (3)-year intervals; and**

5 **WHEREAS, the Legislative Council determines that it is in the Nation's best interest to secure**
6 **"Mature Contract" status, as that term is defined in Section 4 of the Indian Self-**
7 **Determination and Education Assistance Act of 1975, 25 U.S.C. Section 450(b), to extend**
8 **the Indian Health Service Master Contract for an indefinite term; and**

9 **WHEREAS, this proposal has been reviewed by the Budget and Finance Committee, which**
10 **recommends approval by the Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council approves**
12 **Amendment No. 3 to the Indian Health Service Master Contract substantially in the**
13 **form attached hereto to secure Mature Contract status.**

14 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Tohono**
15 **O'odham Nation's Chairman to negotiate and execute Amendment No. 3.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
17 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 1,974.55 FOR; 92.25**
18 **AGAINST; [01] NOT VOTING; and 528.70 [07] ABSENT, pursuant to the powers vested in the Council**
19 **by Article VI, Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the**
20 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**


