2	maintenance of law and order and the administration of justice." (Constitution of the
3	Tohono O'odham Nation, Article VI, Section 1(c)(6)); and
4	WHEREAS, a case is currently pending in the Ninth Circuit Court of Appeals, <i>Miranda v. Nielsen</i>
5	which challenges the legality of criminal sentences imposed in excess of one year or
6	multiple counts in tribal courts under the Indian Civil Rights Act; and
7	WHEREAS, the Tohono O'odham Nation Judicial Court sentences in excess of one year, when there
8	is a conviction on multiple counts and where it is warranted in the interests of justice
9	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it authorizes

10	and approves the filing of an <i>amicus curiae</i> brief in <i>Miranda v. Nielsen, et al.</i> and
11	related cases in the Ninth Circuit Court of Appeals and the United States Supreme
12	Court, if warranted, in support of the position that the imposition of a crimina
13	sentence in excess of one year based on multiple counts is legal under the Indian Civi
14	Rights Act.
15 16	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>09TH Day</u>
17	of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,184.50 FOR; -0- AGAINST
18	206.30[03] NOT VOTING; and 204.70 [06] ABSENT, pursuant to the powers vested in the Council by
19	Article VI, Section 1 (c)(6) of the Constitution of the Tohono O'odham Nation, adopted by the
20	Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistan
21	Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
22	18, 1934 (48 Stat. 984).
