

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Endorsing Vince Rabago's Candidacy for Arizona Attorney General)

RESOLUTION NO. 10-209

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **authority to consult with state and local governments and to "promote, protect and**
3 **provide for public health, peace, morals, education and general welfare of the Tohono**
4 **O'odham Nation and its members" (Constitution, Article VI, Section 1 (c)(2)); and**

5 **WHEREAS, in November 2010, the State of Arizona will hold an election to elect a candidate as**
6 **Arizona Attorney General; and**

7 **WHEREAS, former Assistant Arizona Attorney General Vince Rabago, an Arizona native, has**
8 **served the State of Arizona as a prosecutor of business fraud cases for the Attorney**
9 **General's Consumer Protection division; and**

10 **WHEREAS, Vince Rabago recognizes and supports the unique trust relationship between the**
11 **United States of America and sovereign Native American tribes such as the Tohono**
12 **O'odham Nation; and**

13 **WHEREAS, Vince Rabago understands the importance and benefit of an effective and productive**
14 **state-tribal relationship; and**

15 **WHEREAS, during the May general session, Mr. Rabago presented information and answered**
16 **questions about his candidacy before the Tohono O'odham Legislative Council; and**

17 **WHEREAS, the Tohono O'odham Legislative Council endorses and supports Vince Rabago's**
18 **candidacy for Arizona Attorney General, the Council also encourages the Nation's**
19 **members to vote as they deem appropriate.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
21 **endorses and supports Vince Rabago's candidacy for Arizona Attorney General.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
23 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 1,086.65 FOR; 622.55**
24 **AGAINST; 681.60[06] NOT VOTING; and 204.70 [06] ABSENT, pursuant to the powers vested in the**
25 **Council by Article VI, Section 1 (c)(2) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
