4	WHEREAS, the Tohono O'odham Legislative Council approved additional funding to the San
5	Xavier Allottee Association, Inc. Board from the SAWRSA Trust Fund in the amount of
6	\$47,631.00 to fund an additional four months of the SAWRSA Allottee Project by
7	Resolution 04-015; and
8	WHEREAS, the TohonoO'odhamLegislativeCouncilapprovedtheSanXavierAllotteeAssociation
9	(SXAA) Budget Amendment #1 to use Carryover SAWRSA Trust Funds in the amount of
10	\$17,338.00 to implement the Southern Arizona Water Rights Settlement Act by
11	Resolution 05-691; and
12	WHEREAS, a remaining balance in the amount of \$13,820.21 is left over from the two combined
13	amounts that were previously approved by the Legislative Council; and
14	WHEREAS, the Board of the San Xavier Allottees Association, Inc. has reviewed the remaining
15	fundsandhaveapprovedafourmonthbudgetforfiscalyear2009byResolution07-15-1000byResolution07-1000by
16	2009; and
17	WHEREAS, the board members find that funding is needed to carry out the duties that are
18	required of the board to meet the needs of all Allottees.
19	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council continues to
20	support the objectives of the original request for funds and approves the four month
21	2010 budget from carryover budget fiscal year 2005-2006 to current fiscal year 2010 in
22	the amount of \$13,820.21 to be used by the San Xavier Allottees Association, Inc.
