

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving San Xavier Allottee Association (SXAA) to use Carryover 2005-2006 SAWRSA Trust Funds for continued work towards the Implementation of SAWRSA)

RESOLUTION NO. 10-214

1 WHEREAS, the Tohono O'odham Legislative Council originally approved funds to the San Xavier
2 Allottees Association, Inc. from the SAWRSA Trust Fund in the amount of \$62,429.00 for
3 the Allottees SAWRSA Project by Resolution 02-114; and

4 WHEREAS, the Tohono O'odham Legislative Council approved additional funding to the San
5 Xavier Allottee Association, Inc. Board from the SAWRSA Trust Fund in the amount of
6 \$47,631.00 to fund an additional four months of the SAWRSA Allottee Project by
7 Resolution 04-015; and

8 WHEREAS, the Tohono O'odham Legislative Council approved the San Xavier Allottee Association
9 (SXAA) Budget Amendment #1 to use Carryover SAWRSA Trust Funds in the amount of
10 \$17,338.00 to implement the Southern Arizona Water Rights Settlement Act by
11 Resolution 05-691; and

12 WHEREAS, a remaining balance in the amount of \$13,820.21 is left over from the two combined
13 amounts that were previously approved by the Legislative Council; and

14 WHEREAS, the Board of the San Xavier Allottees Association, Inc. has reviewed the remaining
15 funds and have approved a four month budget for fiscal year 2009 by Resolution 07-15-
16 2009; and

17 WHEREAS, the board members find that funding is needed to carry out the duties that are
18 required of the board to meet the needs of all Allottees.

19 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council continues to
20 support the objectives of the original request for funds and approves the four month
21 2010 budget from carryover budget fiscal year 2005-2006 to current fiscal year 2010 in
22 the amount of \$13,820.21 to be used by the San Xavier Allottees Association, Inc.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day
24 of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
25 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,
26 Section 1 (d)(2) & (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
27 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
29 Stat. 984).
