1 **WHEREAS, the Tohono O'odham Legislative Council is empowered to approve, amend, and modify**
2 **budgets that have been previously approved; and**

3 **WHEREAS, the Tohono O'odham Legislative Council by Resolution Number 09-600, approved the**
4 **San Lucy District FY 2010 Budgets and Resolution Number 10-135, Approved the San**
5 **Lucy District Elderly Program Budget Amendment #1; and**

6 **WHEREAS, resolution number SL 06-55-10 of the San Lucy District Council approved the San Lucy**
7 **District Council Budget Modification #1 that addresses over expenditures in several**
8 **line items, reallocation of funds from the San Lucy District Administrative Budget in**
9 **the amount of \$13,244.60; approved the San Lucy District Administration Budget**
10 **Modification #1, addressing over expenditures and reduction and reallocation of**
11 **funds to the San Lucy District Council's Budget and Human Services Budget in the**
12 **amount of \$18,744.60; approved the San Lucy District Human Services Budget**
13 **Modification #1, to cover over expenditures and incorporate additional funds from the**
14 **Administrative Budget in the amount of \$5,500.00; and**

15 **WHEREAS, the Tohono O'odham Legislative Council - Budget and Finance Committee reviewed**
16 **the San Lucy District Budget Modifications/Amendments, and approved too forward**
17 **the Budget Modifications/Amendments to the Tohono O'odham Legislative Council for**
18 **consideration.**

19 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council hereby approves the**
20 **attached San Lucy District Council Budget Modification/Amendment #1; San Lucy**
21 **District Administrative Budget Modification/Amendment #1; San Lucy District**
22 **Administrative Budget Modification/Amendment #1.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
24 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,396.80 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and 198.70 [07] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
27 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
