

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving amendment 3 to the Water Resources Department FY10 budget 21-1525 to decrease line item 810 PROFESSIONAL SERVICES by \$14,430.04 and to increase line item 750 MAJOR CAPITAL EQUIPMENT by \$14,430.04, for a total budget of \$2,301,377.44)

RESOLUTION NO. 10-217

1 WHEREAS, the Tohono O'odham Legislative Council approved amendment 2 to the Water
2 Resources Department FY10 budget 21-1525 through Resolution 10-088, in the amount
3 of \$2,301,377.44; and

4 WHEREAS, the Water Resources Department is requesting the approval of amendment 3 to
5 decrease line item 810 PROFESSIONAL SERVICES by \$14,430.04 and increase line item
6 750 MAJOR CAPITAL EQUIPMENT by \$14,430.04, for a total budget of \$2,301,377.44; and

7 WHEREAS, amendment 3 to the FY10 budget 21-1525 has been reviewed by the Legislative Water
8 Resources Committee and the Budget and Finance Committee.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
10 amendment 3 to the Water Resources Department FY10 budget 21-1525 to decrease
11 line item 810 PROFESSIONAL SERVICES by \$14,430.04 and increase line item 750
12 MAJOR CAPITAL EQUIPMENT by \$14,430.04, for a total budget of \$2,301,377.44, in
13 accordance with the budget attached hereto.

14 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
15 Chairperson and any designated official to expend and administer the budget, as
16 attached, provided that any amendments affecting the funds or funding levels of the
17 budget shall be submitted for further prior approval by the Tohono O'odham
18 Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day
20 of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;
21 -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,
22 Section 1 (f) and (j) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
23 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
24 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
25 Stat. 984).
