to move monies within line items and add a Major Capital line item)

RESOLUTION NO. 10-220

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Tohono O'odham Gaming**
2 **Office FY10 Budget 01-1004, in the amount of \$4,674,790.88 with Resolution No. 09-268;**
3 **and**

4 **WHEREAS, the Tohono O'odham Gaming Office is requesting approval by the Tohono O'odham**
5 **Legislative Council to move monies within line items and establish a Major Capital line**
6 **item (750); and**

7 **WHEREAS, the Tohono O'odham Gaming Office is moving monies to cover for the purchase of a**
8 **software module as Phase 1 to be utilized by the Tohono O'odham Gaming Office staff**
9 **and increasing Supplies - Office (720) for the remainder of the fiscal year and**
10 **decreasing other line items; and**

11 **WHEREAS, the Tohono O'odham Gaming Office has assessed the need to change Budget 01-1004**
12 **with Amendment 1 and presented amendment #1 to the Commerce Committee and**
13 **Budget and Finance Committee for review.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **Tohono O'odham Gaming Office Budget Amendment #1 to move monies within line**
16 **items, as attached hereto:**

- 17 **1. Increase line item 720 - Office Supplies.**
- 18 **2. Decrease line items 650 - Tuition & Registration, 655 - Lodging, 661 - Mileage POV,**
19 **721 - Supplies Other, 722 - Program Supplies, 810 - Professional Services and 855 -**
20 **Consumables.**
- 21 **3. Establish a Major Capital line item (750) in the amount of \$35,000.00.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget, as**
24 **attached, provided that any amendments affecting the funds of funding levels of the**
25 **budget shall be submitted for further prior approval by the Tohono O'odham**
26 **Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
28 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
29 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
30 **Section 1 (d)(2)&(3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**
