

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Tohono O'odham Nation Delegation to the National Congress of American Indians' 2010 Mid-Year Conference)

RESOLUTION NO. 10-222

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to consult with the**
2 **federal government and other Indian tribes on all matters within the Council's**
3 **authority (Constitution of the Tohono O'odham Nation, Article VI, Section 1(f)); and**

4 **WHEREAS, the National Congress of American Indians ("NCAI") will hold its 2010 Mid-Year**
5 **Conference in Rapid City, South Dakota from June 20 - 23, 2010; and**

6 **WHEREAS, the Tohono O'odham Nation has worked closely with NCAI and with Indian tribes**
7 **across the United States to address numerous national issues of importance to Indian**
8 **people; and**

9 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to continue its national-level**
10 **involvement in these issues by participating in the NCAI 2010 Mid-Year Conference.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
12 **authorizes Chairman Ned Norris, Jr. to serve as the Nation's voting delegate and**
13 **Councilman Timothy Joaquin and Legislative Vice-Chairwoman Felicia Nuñez to serve**
14 **as the Nation's alternates to the NCAI 2010 Mid-Year Conference; provided that the**
15 **voting delegate, alternates, and any Legislative Council representatives attending the**
16 **NCAI Mid-Year Conference are authorized to present and advocate for resolutions and**
17 **positions previously approved by the Tohono O'odham Legislative Council.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
19 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,271.50 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and 324.0[09] ABSENT, pursuant to the powers vested in the Council by Article VI,**
21 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
