

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the U.S. Department of Health and Human Services Centers for Disease
Control and Prevention (CDC) Comprehensive Cancer Control Planning Grant
Award, Account 11-1446)

RESOLUTION NO. 10-227

1 **WHEREAS, cancer is an increasing health risk for members of the Tohono O'odham Nation; and**
2 **WHEREAS, it is important to finalize a comprehensive plan to address this health risk; and**
3 **WHEREAS, a five year grant was awarded to the Tohono O'odham Nation beginning June 30, 2007**
4 **- June 29, 2012, the first year is a one year planning grant to start June 30, 2008 - June**
5 **29, 2009 in the amount of \$120,370.53; and**

6 **WHEREAS, the Tohono O'odham Legislative Council approves and authorizes expenditures in the**
7 **following:**

- 8 **1. The U.S. Department of Health and Human Services, Centers for Disease Control**
9 **and Prevention (CDC) third year final grant award of \$136,925.00 for budget period**
10 **June 30, 2009 - June 29, 2010 with attached budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
12 **authorizes expenditures in the following:**

- 13 **1. The U. S. Department of Health and Human Services, Centers for Disease Control**
14 **and Prevention (CDC) third year revised grant award adding \$16,590.00 for a total**
15 **of \$153,515.00 for budget period June 30, 2009 - June 29, 2010 with attached budget.**
- 16 **2. That the funds will be utilized by the Tohono O'odham Department of Health and**
17 **Human Services to develop a plan for coordinated Cancer Prevention and Control.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation officials to wit: the Chairperson, Vice**
19 **Chairperson or any designated official is hereby authorized to negotiate and execute**
20 **the grant, provided however, that any amendments affecting the funding or funding**
21 **level shall be submitted for approval by the Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (i) and (j) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
