5	WHEREAS, a final draft Tohono O'odham Nation Comprehensive Cancer Prevention and Control
6	Plan 2010-2015 has been reviewed and accepted by the Tohono O'odham Legislative
7	Council on October 23, 2009 and reviewed and suggestions provided by the Centers for
8	Disease Control and Prevention; and
9	WHEREAS, the final draft Tohono O'odham Nation Comprehensive Cancer Prevention and
10	Control Plan 2010-2015 has been edited, graphics have been added and it is now
11	important to finalize the plan.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
13	accepts the Tohono O'odham Nation Comprehensive Cancer Prevention and Control
14	Plan 2010-2015.
15	BE IT FURTHER RESOLVED that the Tohono O'odham Nation Comprehensive Cancer Prevention
16	and Control Plan 2010-2015 will be utilized by the Tohono O'odham Cancer
17	Partnership to implement coordinated cancer prevention and control.
18	BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials to wit: the Chairperson, Vice
19	Chairperson or any designated official is hereby authorized to negotiate and execute
20	the grant, provided however, that any amendments affecting the funding or funding
21	level shall be submitted for approval by the Legislative Council.
