

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting the final Tohono O'odham Nation Comprehensive Cancer Prevention
and Control Plan 2010-2015)

RESOLUTION NO. 10-228

1 **WHEREAS, cancer is an increasing health risk for members of the Tohono O'odham Nation; and**
2 **WHEREAS, a five year grant was awarded to the Tohono O'odham Department of Health and**
3 **Human Services beginning June 30, 2007 – June 29, 2012 to develop and implement a**
4 **comprehensive prevention and control plan; and**

5 **WHEREAS, a final draft Tohono O'odham Nation Comprehensive Cancer Prevention and Control**
6 **Plan 2010-2015 has been reviewed and accepted by the Tohono O'odham Legislative**
7 **Council on October 23, 2009 and reviewed and suggestions provided by the Centers for**
8 **Disease Control and Prevention; and**

9 **WHEREAS, the final draft Tohono O'odham Nation Comprehensive Cancer Prevention and**
10 **Control Plan 2010-2015 has been edited, graphics have been added and it is now**
11 **important to finalize the plan.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
13 **accepts the Tohono O'odham Nation Comprehensive Cancer Prevention and Control**
14 **Plan 2010-2015.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Comprehensive Cancer Prevention**
16 **and Control Plan 2010-2015 will be utilized by the Tohono O'odham Cancer**
17 **Partnership to implement coordinated cancer prevention and control.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation officials to wit: the Chairperson, Vice**
19 **Chairperson or any designated official is hereby authorized to negotiate and execute**
20 **the grant, provided however, that any amendments affecting the funding or funding**
21 **level shall be submitted for approval by the Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day**
23 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**
25 **Section 1 (c)(2) and 1 (d) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
26 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
