

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the U.S. Department of Health and Human Services Centers for Disease
Control and Prevention (CDC) Comprehensive Cancer Control Planning Grant
Award, Account 11-1446)

RESOLUTION NO. 10-229

1 WHEREAS, cancer is an increasing health risk for members of the Tohono O'odham Nation; and
2 WHEREAS, it is important to finalize a comprehensive plan to address this health risk; and
3 WHEREAS, a five year grant was awarded to the Tohono O'odham Nation beginning June 30, 2007
4 - June 29, 2012.

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
6 authorizes expenditures in the following:

- 7 1. The U.S. Department of Health and Human Services, Centers for Disease Control
8 and Prevention (CDC) fourth year final grant award of \$225,000.00 for budget
9 period June 30, 2010 - June 29, 2011 with attached budget.

10 BE IT FURTHER RESOLVED that the funds will be utilized by the Tohono O'odham Department of
11 Health and Human Services to develop a plan for coordinated Cancer Prevention and
12 Control.

13 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
14 Chairperson and any designated official to expend and administer the budget as
15 attached, provided that any amendments affecting the funds or funding level shall be
16 submitted for further prior approval by the Tohono O'odham Legislative Council.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
18 of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,273.15 FOR; 92.25
19 AGAINST; 230.10 [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council
20 by Article VI, Section 1 (i) and (j) of the Constitution of the Tohono O'odham Nation, adopted by the
21 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
22 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
23 18, 1934 (48 Stat. 984).


