RESOLUTION NO. 10-230

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on June 11, 2010 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, on June 4, 2010, at a regularly scheduled meeting, the Gu Achi District Council did**
4 **approve budget amendments for Cababi (*Amendment #1, Resolution #0610-200*),**
5 **Santa Rosa (*Amendment #3, Resolution #0610-201*), North Santa Rosa (*Amendment #3,***
6 ***Resolution #0610-202*), Florence (*Amendment #2, Resolution #0610-203*) and Palo**
7 **Verde Stand (*Amendment #3, Resolution #0610-204*) Communities as attached hereto;**
8 **and**

9 **WHEREAS, the Tohono O'odham Legislative Council's Budget and Finance Committee did review**
10 **the communities' budget amendments submitted by the Gu Achi District and**
11 **recommend for approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Gu Achi District FY 2010 Budget Amendments for Cababi (*Amendment #1*),**
14 **Santa Rosa (*Amendment #3*), North Santa Rosa (*Amendment #3*), Florence (*Amendment***
15 ***#2*) and Palo Verde Stand (*Amendment #3*) Communities as attached hereto.**

16 **BE IT FURTHER RESOLVED that the amendment does not affect the overall portion of the Gaming**
17 **Distribution of \$1,863,072.77 to the Gu Achi District.**

18 **BE IT FURTHER RESOLVED that the Gu Achi District Council has the authority to modify its Fiscal**
19 **Year 2010 budget in accordance with protocols set forth by this Council. Any**
20 **amendments affecting the funds or funding levels of the Gu Achi District's Fiscal Year**
21 **2010 budget shall be approved by the Tohono O'odham Legislative Council.**

22 **BE IT FINALLY RESOLVED that this resolution will be executed in an expedient manner.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th Day**
24 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and 187.10 [06] ABSENT, pursuant to the powers vested in the Council by Article**
26 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
