

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Carryover Savings for FY 2010 Bureau of Indian Affairs Judicial  
Service Contract under P.L. 93-638 – Budget Amendment #01)**

RESOLUTION NO. 10-231

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY 2010 Bureau of Indian**  
2 **Affairs Judicial Services Contract under P.L. 93-638 in the amount of \$300,476.00; and**

3 **WHEREAS, the actual funds under P.L. 93-638 for Judicial Services is \$330,881.00, with an increase**  
4 **of \$30,405.00; and**

5 **WHEREAS, there is a need to amend the FY 2010 Bureau of Indian Affairs Judicial Services**  
6 **Contract under P.L. 93-638 to reflect the carryover savings; and**

7 **WHEREAS, the attached budget has been amended to reflect the increase of \$30,405.00; and**

8 **WHEREAS, this Budget Amendment #01 has been reviewed and approved by the Tohono O'odham**  
9 **Nation's Grants and Contracts department; and**

10 **WHEREAS, this Budget Amendment #1 has been reviewed and approved by the Tohono O'odham**  
11 **Judiciary Committee and Budget and Finance Committee.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does approve the FY 2010 Bureau**  
13 **of Indian Affairs Judicial Service Contract under P.L. 93-638 carryover savings in the**  
14 **amount of \$30,405.00 with a total of \$330,881.00.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chief Judge and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
20 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**  
21 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
22 **Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
23 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**


