

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving a Consulting Contract with Rocky Hill Advisors, Inc.)

RESOLUTION NO. 10-232

1 **WHEREAS, by Resolution No. 10-115 the Tohono O'odham Legislative Council approved the**
2 **selection of Rocky Hill Advisors, Inc., as an expert in the trust mismanagement**
3 **lawsuits filed by the Tohono O'odham Nation against the United States in the federal**
4 **courts in Washington, D.C.; and**

5 **WHEREAS, the Attorney General has negotiated a contract with Rocky Hill Advisors, Inc., which**
6 **contract has been reviewed by the Domestic Affairs and the Budget and Finance**
7 **Committees, which recommend approval by the Legislative Council; and**

8 **WHEREAS, the term of the contract is from June 14, 2010 to September 30, 2010, and the budget**
9 **for the contract is \$27,000, to be funded by the Professional Services line item of the**
10 **FY 2010 operating budget of the Office of Attorney General.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
12 **Consulting Contract with Rocky Hill Advisors, Inc., in the amount of \$27,000, for the**
13 **period from June 14, 2010 to September 30, 2010, substantially in the form attached**
14 **hereto, and authorizes the Chairman of the Nation to execute it.**

15 **BE IT FINALLY RESOLVED that the Legislative Council hereby authorizes the Chairman of the**
16 **Nation to execute any amendments for extension of time as may be recommended by**
17 **the Attorney General, provided that any amendments to the contract which add funds**
18 **to the budget will be first presented to the Legislative Council for approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
20 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,595.50 FOR; -0- AGAINST;**
21 **-01- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article VI,**
22 **Section 1 (f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
