5	WHEREAS, the Attorney General has negotiated a contract with Rocky Hill Advisors, Inc., which
6	contract has been reviewed by the Domestic Affairs and the Budget and Finance
7	Committees, which recommend approval by the Legislative Council; and

	WHEREAS, the term of the contract is from June 14, 2010 to September 30, 2010, and the budge
9	for the contract is \$27,000, to be funded by the Professional Services line item of the
10	FY 2010 operating budget of the Office of Attorney General.
11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
12	Consulting Contract with Rocky Hill Advisors, Inc., in the amount of \$27,000, for the
13	period from June 14, 2010 to September 30, 2010, substantially in the form attached
14	hereto, and authorizes the Chairman of the Nation to execute it.
15	BE IT FINALLY RESOLVED that the Legislative Council hereby authorizes the Chairman of the
16	Nation to execute any amendments for extension of time as may be recommended by
17	the Attorney General, provided that any amendments to the contract which add funds
18	to the budget will be first presented to the Legislative Council for approval.
