## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Amendment No. 1 to the FY 2010 Budget of the Office of Attorney General)

RESOLUTION NO. 10-233

1	WHEREAS, the Office of Attorney General was created by the Statute Creating the Office of the
2	Attorney General of the Tohono O'odham Nation adopted by Resolution No. 326-89,
3	and has overall responsibility for providing legal advice and representation to all
4	officials, agencies, departments, divisions, and branches of the Nation's government,
5	and for representing the Nation in all legal proceedings; and
6	WHEREAS, the attached Amendment No. $f 1$ to the FY $f 2010$ budget of the Office of Attorney General,
7	budget No. 01-1031, ("Amendment No. 1") adds \$2,000 to 650 Tuition and Registration;
8	\$4,000 to 661 Mileage POV; and \$115,000 to Professional Services, for a total of
9	\$121,000; and
10	WHEREAS, the source of funds for this Amendment No. 1 is \$24,000 in savings from within the
11	budget, and \$97,000 in new funds appropriated from the FY2010 general fund surplus
12	and
13	WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed Amendment
14	No. 1, and recommend approval by the Tohono O'odham Legislative Council.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
16	Amendment No. 1 in the amount of \$121,000 for budget No. 01-1031, utilizing \$24,000
17	from savings from within the budget and \$97,000 from the FY2010 general fund
18	surplus, as one-time funding, changing the budget total from \$1,694,242.89 to a new
19	total of \$1,791,242.89.
20	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council appropriates the amount
21	of \$97,000 from the FY 2010 general fund surplus to fund Amendment No. 1.
22	BE IT FINALLY RESOLVED the Tohono O'odham Legislative Council hereby authorizes the
23	Chairperson and any designated official to expend and administer the budget as
24	attached, provided that any amendments affecting the funds or funding level shall be
25	submitted for further prior approval by the Tohono O'odham Legislative Council.
