1	WHEREAS, the Tohono O'odham Nation's trust mismanagement litigation in the United States
2	Court of Federal Claims has been appealed by the United States to the United States
3	Supreme Court as Case No. 09-846; and
4	WHEREAS, by Resolution No. 07-164 the Tohono O'odham Nation (the "Nation") appointed a trust
5	settlement delegation consisting of the Chairperson of the Budget and Finance
6	Committee, the Chairperson of the Natural Resources Committee, the Chairperson of the Natural Resources, the Natural Resources, the Chairperson of the Natural Resources, the Chairperson of the Natural Resources, the N
7	the Nation, and the Treasurer of the Nation, to provide oversight over the trust
8	mismanagement litigation; and
9	WHEREAS, the Nation's trust settlement delegation has recommended that the Nation appoint
10	the Wilmer Cutler Pickering Hale and Dorr LLP law firm to represent the Nation in the
11	Supreme Court appeal; and
12	WHEREAS, the Attorney General has negotiated an attorney contract with the Wilmer Cutler
13	Pickering Hale and Dorr LLP law firm which has been reviewed by the Domestic Affairs
14	and the Budget and Finance Committees, which recommend approval by the
15	Legislative Council; and
16	WHEREAS, the term of the attorney contract is from June 11, 2010 to September 30, 2010, and the
17	budget for the contract is \$100,000, to be funded by the Professional Services line item
18	of the FY 2010 operating budget of the Office of Attorney General.
19	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
20	attorney contract with Wilmer Cutler Pickering Hale and Dorr LLP, in the amount of
21	\$100,000 for FY2010, for the period from June 11, 2010 to September 30, 2010,
22	substantially in the form attached hereto, and authorizes the Chairman of the Nation
23	to execute it.
24	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16 TH Day
25	of <u>IUNE, 2010</u> at a meeting at which a quorum was present with a vote of <u>2,595.50</u> FOR; <u>-0-</u> AGAINST; -01- NOT VOTING; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Article VI,
