

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Amendment #3 to increase \$312,250.00 to the FY2010**  
**Audit Provisions Budget)**

RESOLUTION NO. 10-235

1 **WHEREAS, the Tohono O'odham Nation Legislative Council approved the FY2010 Audit Provision**  
2 **Budget pursuant to Legislative Council Resolution No. 09-268; and**

3 **WHEREAS, Budget Amendment #2 was presented and approved by the Budget and Finance**  
4 **Committee and the Tohono O'odham Legislative Council; and**

5 **WHEREAS, the Executive Office of the Chairman submits for review and approval FY2010 Budget**  
6 **Amendment No. 3; and**

7 **WHEREAS, the FY2010 Audit Provisions Budget is hereby amended increasing the budget by**  
8 **\$312,250.00 to cover cost to complete the FY2008 District Audits; and**

9 **WHEREAS, the FY2010 Audit Provisions Budget Amendment #3 has been reviewed by the Budget**  
10 **and Finance Committee.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
12 **the Audit Provisions Budget Amendment #3 increasing the original base budget of**  
13 **\$1,022,882.00 by \$312,250.00 for a total budget amount of \$1,335,132.00 and**  
14 **appropriates \$312,250.00 from General Surplus Fund.**

15 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached, provided however that any amendments affecting the funds or funding**  
18 **levels shall be submitted for further prior approval by the Tohono O'odham**  
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24<sup>TH</sup> Day**  
21 **of JUNE, 2010 at a meeting at which a quorum was present with a vote of 2,408.40 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and 187.10[04] ABSENT, pursuant to the powers vested in the Council by Article**  
23 **VI, Section 1 (d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the**  
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
